

### **Board Update**

In October the CEMA board of directors had a planning session to set goals for the remainder of 2023 through the end of 2024. To inform our planning session we used feedback provided by members in the spring 2023 CEMA survey and input received directly to board directors throughout the year.

The 2023 survey results were shared with employee service leaders to help them understand concerns from the collective voice of CEMA members. Top themes included compensation, training or professional development and benefits.
