Health and Wellness

The City provides several programs and services to support the health and wellness of our employees, including coping strategies, mindfulness, building resilience, and physical, mental, and spiritual wellness. Canada Pension Plan Disability

Canada Pension Plan Disability (CPPD) benefits are designed to provide partial income replacement to eligible CPP contributors under age 65 with a severe and prolonged disability, as defined in the Canada Pension Plan legislation.

The CPP disability benefit is a monthly payment you can get if you:

- are under the age of 65
- have made enough contributions to the CPP
- have a mental or physical disability that regularly stops you from doing any type of substantially gainful work, and
- have a disability that is long-term and of indefinite duration, or is likely to result in death
